

## **Declarations For Inmates, Correctional Facilities, and Correctional Staff/Judges**

### **Declarations For Prisoners/Inmates**

Including those awaiting sentencing and those falsely accused:

- Inmates will serve times that are just and fair.
- Inmates will be given nutritious, appropriate healthy foods for adequate living
- Inmates will be treated human, not like animals or worthless objects
- Inmates will be safe from physical, mental, and emotional harm
- They will not serve bigger sentences due to prejudice, racial, or unsolicited mistreatment
- They will learn from this experience, and they will not return
- They will develop and maintain a relationship with our Father in Heaven in Jesus' name
- Inmates will inhabit sanitary, toxin-free environments
- Inmates will get along with other inmates and staff.
- They will not act in behaviors that may cause their sentences to be extended.
- Those who are serving life sentences will find Jesus, and their souls shall be saved.
- They will have an outside support system that visits them, writes to them, and ensures they have everything they need.
- They shall receive food, water, sanitary supplies and all medications and necessary aids in a timely fashion appropriately.
- They will receive proper healthcare and medical attention when necessary in a timely fashion.
- They shall freely have access to mental health aids and counsel or therapy.
- Any of them married shall see their spouses regularly as appropriate without resistance or blocking.
- They will resume full accountability and responsibility for whatever role they played in getting themselves locked up, and they will learn from their mistakes.
- Their families shall withstand this challenge and will not fall apart during or after their served time.
- No illness or sickness shall overtake them.
- We rebuke the spirit of depression and oppression over their lives.
- We bind any attacks of the enemy against them and their families and cast them into the dry places.
- No women nor men shall be susceptible to abuse, rape, or neglect.
- Anyone currently being raped, abused, neglected, or unfairly treated shall receive fair compensation for such treatment, and all those responsible for the poor treatment of those mistreated shall be disciplined and witness the other side of the law appropriately.

- They shall know God's love for them, that He does not despise those who are bound.
- Judges shall sentence them justly and fairly appropriately with the help of the Holy Spirit.

**Luke 4:18-19 ERV**

**[18] "The Spirit of the Lord is on me. He has chosen me to tell good news to the poor. He sent me to tell prisoners that they are free and to tell the blind that they can see again. He sent me to free those who have been treated badly [19] and to announce that the time has come for the Lord to show his kindness." (Jesus quoted from Isaiah 61:1-2; 58:6)**

- Those falsely accused will be exonerated, and they shall receive appropriate restitution for the inconvenience and their pain and suffering.
- Anyone bearing false witness towards the accused shall come clean and rescind their false testimony and face appropriate consequences.
- Those simply imprisoned due to poverty or the color of their skin shall be liberated and fairly compensated for prejudiced treatment
- Those serving sentences longer than what is fair for their crime due to prejudice or injustice shall have their cases re-reviewed and shall be fairly released.
- Any inmates being treated poorly just because they're incarcerated shall receive a fair review and be released or moved to a place where they'll be treated fairly for the remainder of an appropriate sentence.
- The poor should have rights to a fair trial.
- The poor shall not be paired with a public defender in cohorts with the persecution who only wish to intimidate and enforce plea bargains on the innocent or poor to strip them of their abilities to receive public assistance, work, or live in good neighborhoods.
- Anyone facing jail or imprisonment with more suitable alternatives available (such as rehab, camps, therapy, mental health centers, juvenile detention centers, community service, probation, parole, etc.) shall be appropriately matched to an alternative with appropriate sentenced time.
- No one shall be sentenced to death, as only God knows a person's heart, and He is the One and only judge.
- Those imprisoned shall receive adequate options for furthering their education.
- They shall have free access to bibles, church services, counsel from spiritual leaders, baptism, and other opportunities for publicly affirming their faith in Christ.
- They will allow the Holy Spirit to fill them, lead them and guide them during and after serving their sentence.

**Declarations For People w/ Records/Those Released**

- Their mistakes shall not harbor over their heads.

- They will find suitable employment and get back on their feet in a timely fashion.
- They will walk on the straight and narrow, and they will not return to bondage.
- They shall be free from incarceration of the body and also free from bondage in the mind.
- They will forgive themselves.
- Their family, friends, and loved ones shall receive them back into their lives as an equal and changed-for-the-better individual with purpose and calling.
- They will discover and pursue their calling in Christ with the baptism of the Holy Spirit.
- They will find a church home and tribe of believers suitable that helps them grow their faith.
- They will have a support system that encourages them, doesn't judge them, and prays for them.
- They shall be able to support themselves and their families.
- They will turn their experience into something positive, and they will remember those whom are still incarcerated.
- They will receive appropriate therapy and health care to heal mentally, emotionally, and physically.
- They shall not be harassed or assaulted by officers, enforcers of the law, or anyone else seeking vengeance or otherwise.
- Their enemies shall bless and not curse them.
- Now that they have turned their lives around, they have been given another chance at freedom in Christ. Just as they have been forgiven, they shall not reap what they have sown from their former lives.
- They shall honor 1 Peter 2:15-16, and freedom will not be an excuse for foolish doing.
- No one will hold animosity towards them because of their past.
- Their freedom shall be a clean slate, a second chance
- Their children, or anyone else whom they lead, will not follow the wrong footsteps. They will live righteously, and they will never end up in jail or prison.
- Anyone on parole or probation will be treated with respect and dignity. They will not have a PO who wishes to see them fail. Instead, they will be treated fairly and appropriately supported in a proper transition back into the outside world.
- Those released shall be reconciled with their families, loved ones, children, spouses, and friends.
- Anyone who has lost parental rights previously who has truly changed in their hearts will get another chance at parenthood and be re-welcomed back into their children's lives appropriately.
- They shall be healed from any trauma (mentally, physically, or emotional) that is still lingering or oppressing them.
- They will not be judged by their past. People will not view them as their mistakes. God has forgiven them. God has dropped the charges!

**Declarations Over Correctional Facilities/Jails/Prisons/Officers/Judges**

- They will care more about the reform of those they house and not more about business and money for the benefit of themselves.
- Public defenders and other lawyers shall do their jobs to ensure everyone gets a fair trial regardless of any bias they may have.
- Facility staff and officers will treat all with respect and dignity.
- They will not use unnecessary and/or hateful force, nor will they abuse their power and authority.
- They will not sexually, physically, mentally, or emotionally abuse, mistreat, or neglect inmates.
- COs will serve with compassion and behave in a manner aligned with the character of Jesus.
- They will pay inmates fairly for the work that they have done, and they will not treat inmates as slaves.
- They will work to point those they house to Jesus and help inmates discover their purpose in Christ.
- Staff will truly get to know inmates in the halls that they serve so that they can best handle conflict and provide suitable resolutions in difficult times.
- Staff will not act as hypocrites who have forgotten their own mistakes while judging the mistakes of those they guard.
- Guards will act in fairness guarding staff while also protecting the safety rights each inmate holds.
- They will act promptly in the midst of conflict and in the event an inmate is sick, ill, or injured.
- They will not withhold medicine, vitamins and minerals, or any necessity for adequate living from any inmate.
- Any guard or staff member with hatred, bias, or prejudice of any kind in their hearts shall not be a worker or volunteer in any such facilities.
- Anyone who has treated inmates unfairly shall fall on their knees and repent, change their hearts and see to it that they adjust their behavior appropriately.
- Appropriate lighting, electrical systems, temperature, food, water, and medical areas shall be kept up to code, shall be adequate, shall be safe, and shall be appropriately shared or used.
- Officers will not aid and abet inmates in criminal activity or the use or retrieval of drugs, weapons, or other contraband.
- The prison system will prioritize the rehabilitation of inmates and not place receiving grants from the government or monetary gain over reform for inmates or righteous behavior.
- They will seek God for wisdom and allow the Holy Spirit to guide them in all practices, behaviors, or actions.
